### **Plan Review Submission Requirements**

New Construction or Remodeling: Plan reviews are **due at least** 45-days prior construction start date.

New Owner - of an existing site: Plan reviews are due at least 45-days prior to desired opening date under new ownership.

<u>Prior Permitted Establishment with a permit that has been expired for more than 6 months:</u> Plan reviews are **due at least 45-days prior to desired reopening date.** 

#### **Plan Review Fees**

Small Park: (0-10 units): \$125.00 Medium Park (11-20 units): \$225.00 Large Park (21 or more units): \$325.00
