  - Hiring 4 contact tracers
  - o New office assistant will start on 12/21/2020
  - Working on Curative Labs mobile testing
  - o Grievance hearing for dismissed employee has been scheduled
- Health Officer
  - COVID-19 vaccinations have passed clinical trials. Hospitals, EMS, and nursing homes are top priorities for vaccination.
  - Hiring additional contact tracers to help with increased workload
- Environmental
  - Most work is now covid-related, addressing complaints about businesses not enforcing mask use and social distancing

- Clinical
  - o Clinical services postponed due to increased covid cases
  - o Meeting this month to discuss telehealth options
  - o 1 staff member is positive and under home isolation
- Threat Preparedness
  - o Coordinating testing events
  - o Planning for vaccine distribution

Dr. Reidy shared graphs and statistics on COVID-19 in Jefferson County and the Eastern Panhandle. There has been a sharp increase in both the number of cases and the severity of illness.
