How to obtain your Food Handler Card

In order to obtain a Food Handler Card, you must have a <u>current</u> certificate showing you have completed the required accredited course.

To obtain a current certificate

Complete the online course – Cost is \$30.00

- a) Visit our website www.jchdwv.org
- b) Click on Food Safety / Food Handlers Card.

- c) Click on the course button -
 - Please note the **\$30 charge** covers the course, the test, and a <u>2-year</u> food handler card.
- d) You will receive two copies of your food card. Please print and keep one for yourself and give the other copy to your manager. Be sure to keep a copy of your certificate in case you lose your card, as you will need it to obtain a replacement card.

This is the only approved site to obtain a food card

Certificates obtained after April 1, 2020 MUST be from the above link or it will not be accepted.

If you already have a current certificate and just need

<u>a renewal food card</u> – Please read the instructions carefully.

If you already have a current certificate – it must meet the following requirements.

- It must have been obtained prior to April 1, 2020. <u>All certificates obtained after this date must be from the red button link on our website.</u>
- Current = prior certificates must have an expiration date of at least 1 year out from the date you are sending it to us.
- It must be from an ANSI accredited establishment.

If your prior certificate meets all the above requirements you may obtain a one-year card for \$10.00 by sending a copy of your certificate to us.

Starting JANUARY 1, 2022 prior certificates will no longer be accepted.

- You MUST include your phone number on the top of the check
- Include a copy of your certificate and a return address or email so we may mail or email your card and receipt to you.

ATTENTION: Certified Food Protection Managers:

If you have a <u>current</u> ANSI-accredited Certified Food Protection Manager Certificate you do not need to get a food handlers card, however, you must have a copy of your certificate available at your food establishment.
